Hello everyone,

I wanted to convey an update to you all before court so you are able to consider developments.

- The referral for AOT was submitted, and I have a message out to the Coordinator asking what to expect next.
- Endeavor has confirmed that they are planning to move forward with getting Wenke started with services once Wenke has completed the initial evaluation with a AOT psychiatrist.
- The Program Manager of the Police Behavioral Health Team (also at Endeavor, this is the team that conducted the Threat Assessment eval) has indicated that Wenke's case will be presented to the Erie County Threat Advisory Committee this coming Tuesday. This is a proactive effort in the event Wenke does not qualify for AOT. When I asked her for the implications of this, she explained: We utilize ECTAC when we have someone who may need some more interventions. The committee is run by BHT and myself and is made up of law enforcement, Non-profits, private sectors and county/federal representations. If AOT is not an option hopefully the committee can look at alternative options
- Wenke did report to ECMC following his release. He was reportedly assessed for immediate risk of harm and released after also meeting with a social worker. I have the direct number of the LCSW that met with him but she has not returned my calls. Any written report could take up to 30 days to be produced, and a general call to the hospital indicated that these are not psych evals but rather a brief screen to see if someone should be admitted for a 72-hour hold.
- Wenke has been extremely active on social media. Below are examples of posts that may cause concern for his continued release.

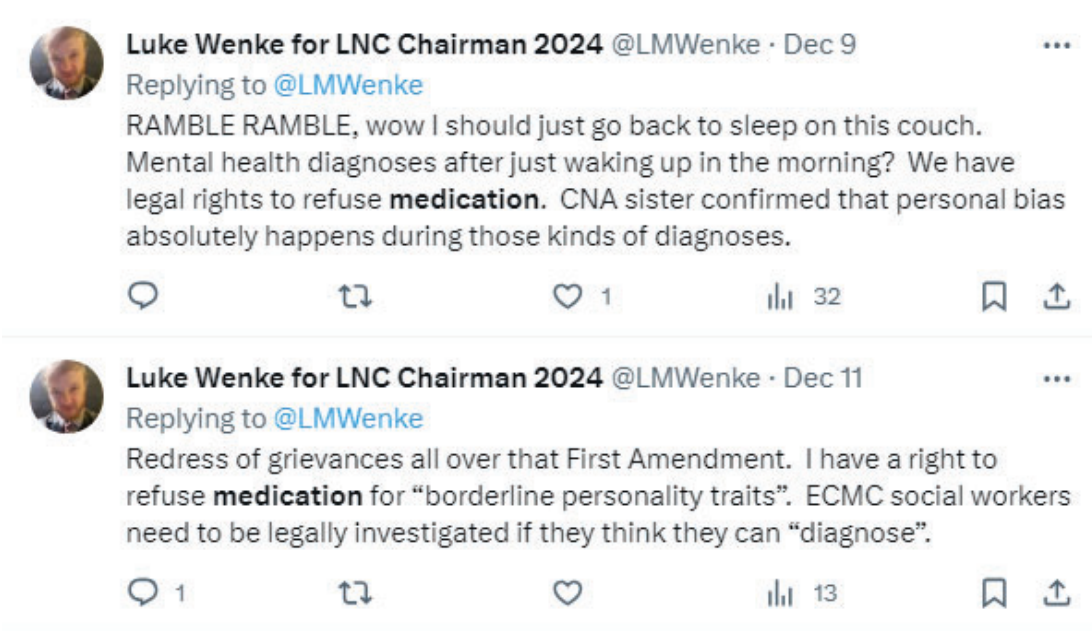
