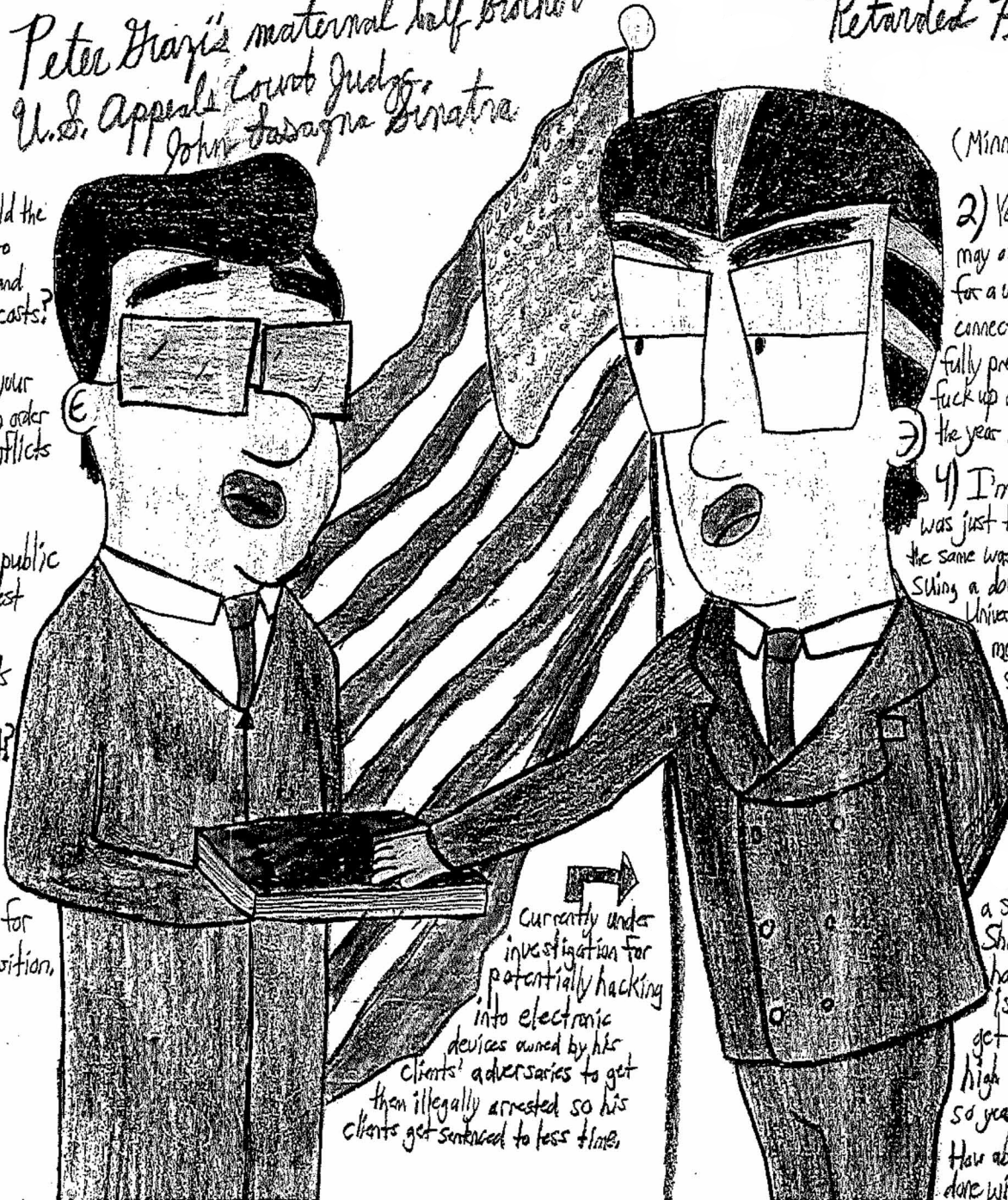
1) Do you solemnly swear to uphold the Constitution and use this position to help the United States seize Greenland and have the upper hand over Denmark at all costs?

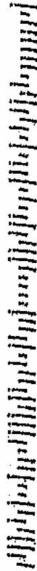
