their legally-likely-to-be forged government documentation I'm not even sure the defense and the
prosecuting attorneys have even seen for themselves? My former stepfather W [REDACTED] J [REDACTED] Emborsky

made it all the way through the NY State Trooper Recruitment Hall of Fame probation employees find more career satisfaction in standing at NY State Trooper recruitment tables at the Walden Galleria mall my very competent mind recalls seeing? NY State Troopers report to Katie [REDACTED]'s house as recent as 2022 as it is so hypothetically defunded and former federal probation employees wouldn't have to lose contact with old colleagues such as the obvious culprit with red hair at play here. ③

Thank you to the Orleans County Jail staff and nobody else for finally moving me out of that miserable mental health rights-violating private room I was in for three months and back to the section of the jail I was in before D [REDACTED] B [REDACTED] of Baltimore MD rudely came in and thrust his make believe alpha status around. Officer Martin did a fine job escorting me a month ago to my face to face attorney client privilege visit with Frank Passafiume and Fonda Kubiak. They asked me questions about this jail but they can't tell Officer Martin how to do his job here. In fact it was the opposite; Frank and Fonda answered to the whims of Officer Martin escorting them at the door they came in so they could go back to their office in Buffalo. I'm sure the B.O.P. transfer center CCA in Youngstown, OH would be more than happy to do the same to absolutely any attorney who showed up ordering CCA staff what to do with unsentenced inmates with inferior court sponsored paperwork likely typed up by Katie [REDACTED].

Awful lot of harsh words and tensions exchanged all year on many fronts. Waiving all further legal road blocks was an option way back in January 2024? It wasn't hard for the Cattaraugus and Chautauque County Libertarian parties pre-Covid to file the joint paperwork needed for Albany NY authorities to place now-state senator George Borrello on the Libertarian line on the ballot in 2019 (George bought me sushi at Oishi in Olean as well as 24/7 cafe food at the Seneca Allegheeny Casino for my mother Janet McCaul and I). So in other words I don't know what's stopping this inferior court from doing the obvious legal step needed to get me to a point

where I am instead getting U.S. Dept. of Labor agreements worked up in this same court ⑨
