

You are the Senior District Judge as I have only recently learned. I am sending this to you with polite intentions as my court circumstances have (finally) reached the Appeals stage.

My mother's mother was Carrollton NY Justice of the Peace Carolyn Giardini. She died in 2020 at the Salamanca NY nursing home where my sister is a CNA. So I come from a life where we have been forced to face with judges under way more personal terms than we are in the condition I am currently in.

I am in Room P2-33 here at Niagara County Jail as I send this out to you. The person in P2-32 is a taller black man on a probation violation in your courtroom. I have listened to his story, and I would like you to consider the fact that probation jams people back into jail no matter what. To me a successful probation duration is doing not one day in jail. No they pressure everyone on their roster to the point of a breakdown. P2-32 has a family to take care of. Bragging to me about all of the certificates from courses he's completed getting all excited for you to review in court is what he did with me. I said ok good but I have a motion to Appeal in from the help of Frank Passafiume, so the Robert H Jackson US District Courthouse is so yesterday to me in terms of this case. I understand P2-32's original case involves Fentanyl. You are a 91 year old federal judge. You would be interested in watching the movie series about John Adams. There is a part where he pleads to Judges in the Netherlands and the Judges scoff at John Adams as he asks for a "modest" amount of money in the Revolution and they tell him "Mr. Adams the Netherlands were a Republic before America was an idea". In the 21st century you are fully aware of the more progressive civil rights reality in Amsterdam surrounding the vice industries. Fentanyl may have killed my brother's brother in 2015, but a Salamanca High School Class of 2010 classmate of mine Courtney Atkins died in 2021 of alcohol poisoning. Pope Francis liked the coca plant, Steve Jobs claimed coming up with the iPhone on LSD. You are a much "higher" judge than the position my Catholic grandmother was, so I ask you to consider "in defense of the forbidden fruit", Adam and Eve attained the ability to see and Jehovah made up for the transgression by giving them clothing. Donald Trump's friend Joe Rogan is an advocate of DMT, which very much activates the largely calcified pineal gland of the brain. So rather than continuing to ramble, I ask you to just consider that P2-32 has a family to take care of, he has sound judgment in his family's needs, and federal probation jams everyone back into jail no matter what as they are all a bunch of tax subsidized

I have given P2-32 US Appeals Judge Debra Ann Livingston's information so he, a father, doesn't have to feel submissive to his circumstances. In defense of all Judges at the Robert H Jackson US Courthouse, do consider the pursuit of the abolition of federal probation entirely and hold their hands one by one helping them find private sector security jobs so they can ~~actually~~ contribute to the tax base for once so none of your courtrooms are defunded by the presidential administration in the end.

It is said that you "won't retire until you sentence people collectively who appear in your courtroom up to one million years". Then I hear you are under investigation for sleeping during trials. First of all on your part I recommend 5 Hour Energy drink capsules from 7/11. Your circulatory system is not too old to handle 5 Hour Energy. his dehumanizing gag order. I absolutely got a corrections officer in trouble here at **Niagara County Jail** in trouble for helping P2-36 get cocaine into the facility. Can you imagine if **Peter Grazi** was suffering a humanitarian issue while in incarceration and wasn't allowed to speak out about it? Last year I was absolutely getting **Orleans County Judge Sanford Church** investigated by the **NY Commission on Judicial Conduct** for conflicts of interest issues. Glad to see a year later I have the attention of authorities higher than John Sinatra aware of my elongated circumstances, and as I've said P2-32 has US Appeals Judge Debra Ann Livingston's information. I now have a copy of what John Sinatra's signature looks like and how easy it is for Debra Ann Livingston to be told he notarized his own resignation since he allowed the evidence exempt conviction of the **Abu Ghannem** family in his courtroom. Americans fight royalty since 1776, and I know of no noteworthy accomplishments from any Sinatra since Frank Sinatra 100 years ago. It is my great great grandfather **Egildo Martinelli**, a former St. Bonaventure University music professor, who played organ for a Pope as his living grandson/my first cousin twice removed/**Carl Paladino's** friend [REDACTED] of the Haunted Hinsdale House can confirm.

Post-Capitol Riot, it is our former Congressman Tom Reed who resigned due to sexual misconduct allegations. At least the general public knew who he was. The general public has never heard of any of the Judges at the Robert H Jackson US Courthouse. I invite you to look into the prison story of former Italian President **Alessandro Pertini** who

All these things I hear about "Richard Arcara holds court hearings over video call from his Florida house and he wants a collective 1 million years out of everyone" appears to be similar to the story of Alessandro Pertini's transgressions.

I do not want to see a 91 year old like you fall victim to ageist prejudice as I have. Stated the odds are against the entire Robert H Jackson US Courthouse in the present. But I am at a point with our present world climate that I no longer want to hear 100 year old American WWII Veterans acting like history's greatest liberators as it was Russia who helped them win in the end. America joined forces with Russia in 1945 to put the DMZ up in Korea, and today it is Russia siding with the Kim family who are nothing more than a Jehoiachin of Judah story of the modern era having done more than enough time isolated from the world. I was born a US citizen and this has been a degrading yet educational 3+ years, so I am more than happy to push the envelope on causes beyond my own interests.

I have come to terms with how I got to where I am today. Nobody deserves to feel like their life is threatened. Oh but I too have a righteousness factor to my end of things. I invite ~~you~~ the 91 year old expert Judge to ~~save~~ yourself and push for the resignation of John Sinatra in a world where everyone has seen my handwriting published on the internet and now as I move up to the Appeals Courts and we all have a copy of John Sinatra's signature, might I recommend Marianne Mariano as his replacement as she has experience being face to face with defendants, as opposed to John Sinatra, and I see a desperate need for a feminist touch at the Robert H Jackson US Courthouse. John can pop up her court by opening up NY State's gold-plated top ranking private firm so he can learn the merits of criminal defense and better help people like Peter Gazi who he knows and help reclaim the Sinatra American has been name. The Kardashians were Old Testament Solomon lawyers who saved OJ Simpson. Consider abolishing probation first.
