



I am writing this to the court on day one of an indefinite lockdown at this facility. We are told this could last at least a week. I was only recently told by Officer Childress that I am not even on the correct floor of this building for someone like me who is here for a competency analyses. I am on the 17th floor where people are on pre-trial. Marcos Torress causes me no problems as a cellmate, but I do not understand this facility's lack of organization which placed me on a floor like this. I have seen Officer Nelson three times as of my sending this out, she is the competency analyst. I don't know why she didn't tell me I'm on the wrong floor.

I am going to warn about my willingness to sue over voter suppression accusations against everyone in this court if I am not at least given an early voting absentee ballot before Election Day. I am a registered Conservative voter and I was once one of State Senator George Borrillo's third tier top donors before this everlasting arrogant life interruption was thrown at me. I have a right to be sentenced without inordinate delay, and it has been a year ever since this 9 month maximum violation began. I have quite a case to be made to Donald Trump 2024 HQ when I say it's a judge approved by Nancy Pelosi/AOC's Congress who denied Byron Brown's primary opponent ballot access back in 2021. Frank emailed my father that I was to be here 30 days, Officer Nelson and the second I saw told me there's a 45 day time limit. I have diversity of jurisdiction here in Chicago and plenty of stamps to make it through this indefinite lockdown to get the US Marshals to serve papers to anyone I need to have them served to. Relatives have no clue what is going on with me as I am unable to call and

Frank said "let's end probation" to me at the end of January 2024 as you all have heard me say from previous phone calls I know you listen to. I would assume instead of working for Marianne Marign's cubicle labyrinth forger, public defenders would want to one up their careers and take advantage of all the lawsuits waiting to happen with this case.

We could sue Michael Crick of the Salamanca Planning Board and accuse him of taking a public office solely to avoid arrest due to whatever he did to his upstairs neighbor that made his get an order

of protection against him. He said to me my "drama was catching up" to me Dec. 2021, two months before this happened to me, but I sure am sick of this 4+ year long crystal ball bullshit claiming me and a 26 year old homeschooled Muslim convert are the next Pete and Chasten. I don't let inmates touch me like that, my father's interview statement concerning me being "submissive" was and is still inaccurate, so I think Mark [REDACTED] and his dominatrix cougar need to stop using my house while this drags on and on so me and the 26 year old homeschooled Muslim convert can do what "electricrubber" on Recon does. You all deal with sex crimes on paper, you can handle looking at "electricrubber" (Matthew [REDACTED] Atkinson of Sheffield, UK) on Recon since a Minnesota attorney you all know is documented by the FBI as being a Recon enthusiast.

Does the Nancy Pelosi judge have a significant other on his Wikipedia yet? I'm happy my very competent mind remembers hearing "let's just waive things" or something along those lines on July 30th as well as Frank telling me "let's end probation" January 2024 right to my face. I think let's book that Fed Jet flight with the US Marshals asap before Election Day, MAGA 2024. Let's not testify in court at all. Let's just Plead The Fifth and use our right to remain silent if [probation officer] steps out of line and moves for everyone to testify in court. Let's dip into the probation budget and all go to the Walden Galleria Food court and talk loudly over all the background noise.

Let's not tell SIS officers at this facility that this court could reindict me on interstate threats. I'm competent and remember my conversation with them along with their lie right to my face.
