Katie's willingness to call Orleans County Jail without having been told to do so by anybody in this court situation in an attempt to get me in trouble has put her in a dilemma in terms of this situation. "Repeat offender" and "pattern of activity" the court system has to say about people who find themselves in the criminal position. Katie went to jail once for selling drugs while she was an N.Y. U. student; at least that's what I recall her saying to me and my mother Janet McCaul when I found myself at Niagara County Jail early 2022. So she knows what a repeat offender is as well as pattern of activity. She was not instructed to lie to the [REDACTED] Police about me September 2023, she very clearly did so herself. April 2024 she does the same thing again; she called Orleans County Jail complaining about what I had to say over these letters to the court. I know integrity and truth are serious values acknowledged by this courtroom so I highly doubt anyone is giving her a whitewash to scribble out anything I am saying over these letters after I send them out from this place and once they reach the court to put things down in writing I wouldn't otherwise say. Or did I just write that prior sentence in Luke Wenkes handwriting and smudge Luke Wenkes fingerprints all over this paper in an attempt to cover up what else might be going on behind the scenes in terms of this case?

I'm growing quite weary of asking redundant questions, so it's time for new ones. Orleans Police Officer Pavlock knows who Katie [REDACTED] is. He doesn't legally answer to this case in the courtroom; not yet at least. Is he willing to befriend whichever [REDACTED] Police Officer Katie lied to September 2023 so they can both join forces and introduce themselves to the New York State Troopers who documented Katie as a "schizophrenic" on paper in 2022 after my mother called on her? How exactly is this courtroom going to trust Katie's ever growing list of

public safety concerns as I try to get that blighted Olean house for her? Get the newest Harvard Ivy League alumni at the prosecutor's office to indict her accordingly; have Kellen Lingley at the Olean Times Herald to publish the article on Facebook (he remembers Katie), tag former Tally's employee [REDACTED] down below (Katie sure did abuse Pat's 6 digit salary so hard he wound up homeless) and let's dig up more on Katie's sugar fitching past. Maybe her N.Y.U. drug dealing past, too... #MPMA2014

Maybe Joe Exotic's federal medical center can cure Katie Valentine's New York State documented schizophrenia. Either we put her there for 11 months so she can eventually get expunged after the federal equivalent to New York State's Clean Slate Act passes into law, or we get the previously mentioned police officers to escort me and her in between those face to face meetings required to get her that Olean blighted house. I know Bill Aiello and John Crawford of the Olean city government can help me acquire to put into her name, have Housing and Urban Development pay Kevin Dougherty's work crew to fix up for her, and then she can be

No microwaves for us to use, no pull up bars to exercise, and broken plumbing in three rooms in my section of the building. Richard Greer is in here complaining about losing muscle mass since coming here and protein deficient meals. Staff is fine, but hardly any hot meals,

the Eternal Leader of the Orleans Stray Cat Society so her army of feline warriors can meow very loudly at and scratch any potential order of protection violaters in the future on Katie's behalf. Men who don't want their own kids just like Katie very clearly don't even have the energy to deal with Katie's N.Y. government documented schizophrenia so we must protect Katie accordingly.

Now questions to ask, eyes eyes, no not redundant ones over these letters to the court. How oh how will this group of people presently attached to this interstate order of protection on "overkill" (a word used in the courtroom late 2023 by an Italian born the same year as my mother) keep a forever watchful eye on one another? I am in here donating stamps, envelopes, paper, and pens to Michael Regan. My fingerprints may be on his stuff. He says he's lost 40 pounds since 2020. On a side note, my cousin [REDACTED] was 56 when he got with 15 year old [REDACTED], Carl Paladino knows [REDACTED]

and I talked about how Katie doesn't like Jamani Croll anymore. Are Ron the Investigator and Katie [REDACTED] still talking after 2 years of knowing each other? I know that Frank Passafiume talked to Katie [REDACTED] on the phone before Katie slammed the phone down on Frank after making bare allegations against Frank that he will never be able to afford to pay Katie for her private stay at home legal secretary work.

Yes yes those are definitely bare allegations from Katie against Frank because a lot of people are talking about Frank Passafiume and Fonda Kubicki's new incoming private federal litigation office to Elliptonville called "716FEDS". After reading through my case paperwork together, they were so inspired by [REDACTED] and Andrew B. [REDACTED]'s shared floor of an obscure Minneapolis skyscraper where they share a unit together that Frank and Fonda decided to explore the idea of opening a private firm partnership in Elliptonville called "716FEDS". So many local government officials back home are talking about 716FEDS and all that it will accomplish, such as contracting the U.S. Space Force into Siemens Dresser Rand of Olean and getting a federal halfway house complex for sex offenders built in Elliptonville through my cousin [REDACTED]'s friend Carl Paladino so they can all go work at Holiday Valley where Canadian tourists don't bother to ask questions about what exactly did their ski lift operator conveniently named Kenneth Ritchie did long ago.
