Judge Sanford Church has him...

The officer who helps [redacted] get Suboxone into this place. That officer told me they're going to help me have undocumented jail visits with Katie since Katie apparently called them again requesting we speak in a supervised setting when the Lieutenant isn't looking.



I promised myself I would not send another letter to the court after how I felt things went on April 16th. Now that I have arrived back to Orleans County Jail under the circumstances that I have on May 2nd, I feel it is necessary to inform the court of legitimate facts provable by many different means.

First of all, all the sudden for no legitimate reason, I have ^{been} placed into my own private room very isolated from the rest of the inmates. I had no problems in the part of this building I have been in since December with people like Richard Greer (hus Vilardo as a Judge). All because [redacted] from Baltimore, MD shows up in that part of this jail in the middle of April, he gets physical with me because he thinks I am out to "snitch" on him or the fact that he thinks I'm racist. Since he thinks he runs that place over in this building where I once was, I am more than happy to inform the court that somehow he is getting Suboxone into the jail for himself as he tries to extort others for payment. I am in a room similar to Michael Regan's room all because I was on the phone talking about [redacted]'s Suboxone. I have absolutely no infractions at this jail to be isolated like this so maybe this rotten jail should be on top of the "to sue" list. It doesn't seem to be for sure that I will always have access to a working phone or even fresh air, so I am sending this letter out to the court for my own obvious self-interests. This jail thinks it's keeping me safe rather than handling [redacted].

When is this nightmare going to end and why do I deserve this still?

I am happy to see that my message to the court concerning Michael Crick of the Salamanca Planning Board who is a self-declared Lilydale NY credentialed psychic medium has made a difference. I have been on the phone with him from this place and my mother confirmed in the phone that he showed up at her restaurant. So I will start with him. I will start by taking his side of things in life. He is a Democrat and he has told me is related to both James Buchanan and Donald Trump, two Presidents. He is into guys and single himself, so he is naturally going to demand something in it for himself by being called into court to be asked about

Will subpoenaing everyone into the court finally make this all work out in the end?

the ever-present Benjamin Ryan [redacted] issue. There is a Salamanca based mortician he has expressed interest in. We first met him at a Dudley Hotel psychic fair in 2012. He has also made claims that the spirit world has advised him that my mother will wind up with someone named Paul McCord who lives and works in Bradford, PA. He cannot legally drive in NY state until 2025 due to a 2019 Salamanca DUI arrest; my mother cannot drive because she is legally blind so naturally the NY/PA state line has separated my mother and Paul since 2022 when this first happened to me. Michael Crick's second claim past the Benjamin [redacted] question at play is that Michael Crick has also said that my former stepfather Bill Emborsky does not have much longer to live. Bill has had his own Cattaraugus County DUI case since August 2023, he had court again March 2024, apparently he goes again September 2024. Michael Crick's third claim was nothing is that another psychic medium other than himself has apparently informed him that he will become Mayor of the city of Salamanca around the time he gets married. How nice that since December 2023 when I first came to this dump of a jail that the Vatican now allows Catholic Priests to bless same sex pairs. I am so happy to have Bible verses such as 1 Samuel 28 and also 1 Corinthians 12 confirm people like Michael Crick's legitimacy. Let's also not forget the fact that Michael Crick owns his house on [redacted] in Salamanca and that his upstairs neighbor has had an order of protection against him in recent years.

How nice that Benjamin Ryan [redacted] also has a friend like this himself from his life. Her name is Elexya [redacted] and she is from Charleston, SC. She lived with the [redacted] for a year before Covid. There are pictures of her in my FBI Discovery and Katie [redacted] was even recorded on the Niagara County Jail phone saying she has looked up tons of information on Elexya [redacted] in terms of the father of her two kids Bryce Gardner and her Kansas City, MO lover Benjamin Daw. "Lexy" (her nickname) calls herself a starseed psychic from the Pleiadas. I cannot find the Bible verse with that star system along with Orion mentioned but I'm sure a simple Google search would find where I found that star system mentioned in the King James Bible. Brett [redacted] was absolutely happy early 2021 when I dropped off

Lexy in Kansas City, MO. These were the days of me and Brett [REDACTED] actually getting along, like when I made him get the Moderna vaccine like I did. He did not like it when I told him that his oldest son and Lexy once had a drugs based party at his Hampstead house when he and Lauren weren't there. Had I known his oldest son longer than Mr. Benjamin Ryan [REDACTED] would not have felt inclined to go out to Minneapolis in 2020 due to Elexya's influence. Nevertheless, Lauren Ashley [REDACTED] believes in Elexya [REDACTED]'s starseed psychic capabilities and I'm sure Michael Crick would love to vetter out. One week after Benjamin's arrest, Elexya reached out to me telling me all kinds of things Benjamin used to say about me, like how Benjamin Ryan [REDACTED] wanted to hold my hand in front of Minneapolis Chipotle parking lot I took him to May 2020 but he didn't think it was the right time. Even [REDACTED] himself confirmed to me over Recon early 2021 that Lexy was way more involved in influencing Benjamin while out in Minneapolis. Benjamin was allowed to talk to Mark [REDACTED] from Sherburne County Jail but not me or Lexy. Lexy may be a starseed psychic but I am frankly more than happy to confirm she uses it for malicious reasons, such as trying to get men to raid ATMs on her behalf in Charleston December 2020 through what she claims is her own telepathy. This is why Brett loved me dropping her off in Kansas City, MO early 2021 the way I did. Other female psychics I have known over the years such as Gretchen at Lilydale were never as malicious as Lexy was.

Might I also add that Rod Edwards of [REDACTED] Olean NY also claims to go the way of the psychics. I last saw Rod face to face at Brother's Bishop of Olean in 2019 when I hosted the New York Libertarian Convention the day after the presidential debate I held at Olean High School. I talk to Rod frequently through other means. According to Rod as of June 2023, "they" (in his words) threw Benjamin [REDACTED] into Witness Protection straight out of Butner federal prison. A few months later, Officer Paulock of the Olean City Police confirmed the burner number texting me as Katie [REDACTED]. Katie sure did know the slang phrase "Wit-see" right off the bat, since she is of course [REDACTED]'s highest paid stay at home secretary as Frank Passafiume confirmed to me behind closed doors. Since due to this legal

situation it is Michael Crick and Elexya [REDACTED] who are the more credible psychics worth issuing a subpoena for, only legal know it all reading this can confirm that "Witsec" fact for Benjamin [REDACTED] to see if Rod Edwards is the third psychic medium we need to subpoena into John Sinatra's courtroom. Rod claimed Benjamin [REDACTED] wants to do the dom top fucking exclusively to me just like Benjamin [REDACTED]'s friend Elexya [REDACTED] told me he will make me do forced workouts and Michael Crick also says Benjamin [REDACTED] wants to be the only one doing the fucking. This court will subpoena three psychics, even though I claim 2 of 3 are on my side before Benjamin's, and all 3 will testify that I'm the one who needs to wind up the bitch so I might as well just put that in writing right now right away because I'm already expecting it. God Is Watching and I don't lie as it is.

Frank was ^{not} present.
 The guy from Massachusetts Frank set me up with literally asked me if I masturbate to the thought of Benjamin [REDACTED] while in jail. He typed away at light speed accordingly so check his notes. If the court would like me to share the cartoon pictures I've drawn of me and him together then feel free to ask me to.

At what point under these circumstances do any and all psychiatric analyses about me become ludicrous and borderline pseudo science? The prosecutor who went up to my father in October and told him he's taking my side no longer has the right to call me mentally ill right in the courtroom like he did April 16th. Borderline personality traits, if it is truly a "mental illness", is like saying having extra smelly farts makes you a physically ill person. You need to be less than 500 miles away from a B.O.P. facility to go there, in terms of where your home address is. No federal medical center anywhere near that around the Olean 500 mile buffer zone. I am very happy to live in an (allegedly) free country where courts and B.O.P. operate separately. We are now on Month 7 of me pleading guilty to a letter sent from Calaveras County Jail. Fonda Dawn Kubiak whispered into my ear as she sat next to me alongside Alexander Anzalone August 2023 in this very courtroom "Don't worry Luke, sending letters out of jail with no contact orders in place never upheld in court". This was Fonda's way of preparing me the defense side of

Sending that letter to "Only Lauren [REDACTED]" out of Chautauque County Jail. I was going by Fonda Dawn Kubiak's prior legal advice by sending those out of Cattaraugus County Jail. Now here at Orleans County Jail I'm no longer in here with her former client Richard Greer to find out if she's back from her medical leave yet as she told him over legal mail. Now I'm all alone in a room by myself so I can masturbate to the pictures of both Katie and Benjamin the guy from Massachusetts asked me about in peace and quiet.

Dammit, is Katie forging my handwriting again and getting copies of my fingerprints from Officer Krupke's office here at Orleans County Sheriff's Office? #Legalities Matter

I'm very happy to learn that the guy from Massachusetts who Frank set me up with knows what Katie [REDACTED] has said to the court. So allow me to continue being "verbase" (in the guy from MA's words) over this letter to the court to explain to Katie what she brought up about me. I will now respond to Katie's accusations.

No Katie there is absolutely no change in my character and personality. I last recall being at your Hamburg parents' house at the end of 2020. If my memory serves me right then you have a picture of me with black fingernail polish on white holding wine on your couch from that visit. Covid has been a bitch to me, Katie. By Covid I mean the era since 2020, not the disease. I left that crackpot of yours at that Salamanca park in 2021 rather than seeing you face to face because I had guilt lingering over my shoulders. Even Brett will recall me expressing to him an unusual sensation of guilt hanging over me. Brett dedicated quite a lot of time to me early 2021 telling me I had no reason to feel at fault for Benjamin's arrest as if I abandoned him out in Minneapolis. My sensation of guilt made no sense to me until Niagara County Jail. Katie knows the way I attacked [REDACTED]'s private firm ratings is what I used to do on Topix. Katie may even recall very early Topix forum references to a "bisexual Wiccan truck driver." I talked about [REDACTED] and [REDACTED] to the court so I know the "bisexual Wiccan truck driver" reference will bring memories to her. Weeks before FBI got

me in January 2022, this guilt sensation grew stronger. I remember getting my mother Janet to put her money in a bank account with a higher interest rate as I sat in the car telling myself "in case I disappear for a while, this will help". Even Michael Crick told me at his house December 2021 "Your drama is catching up to you" so it's not like even the psychics only tell me things I want to hear. Michael Crick has said things I don't want to hear, too. The drama caught up to me. Even in 2019 while working at Domino's I recall the Olean Police calling me telling me to calm a suicidal teenager in my then-Olean Politics group. I acted too busy to care. Shame on me because the internet attacks against [REDACTED] summarized the prior decade of my internet history. I have spoken with countless inmates these past 2 years who make claims of "feeling their arrest coming". I was very anti-social in 2021. Katie, [REDACTED], Brett [REDACTED] all have that picture of me street entertaining in Vegas. My 2021 travels weren't even enough to cheer me up. I couldn't figure it out back then.

No Katie I have not changed. Our no contact sparring experience at Bryner's Martial Arts with people like Jason Yaw and Jessica Davis affects me even today as it was impossible for me to push [REDACTED] off of me at this place in the last week. Here I am alone in a jail room writing to a court hoping this makes it through to you. My sense of survival has also had to evolve since I naturally don't want to be in here. I am sick of inmates and asking them to explain how the Covid era affected their affairs. These monotonous conversations I have with these people in here helps me attempt to justify how I went this way but I am sick of it. IF Katie had told me in 2021 she works for [REDACTED] then I would have driven her out there to see him the same way I took her to Wisconsin and New England. Perhaps none of this would have happened. I am sure Katie's intense involvement in this situation grows on her nerves, too. I am sure she wants a return to natural human social interaction. She was absolutely in my mother's house when I was at Niagara County Jail as she met [REDACTED] for the first time.

I am going to finish this letter off by making three more points to the court. The first being the shortest point. I am fully aware of Waleed Abughunem's locked plea deal of 18 months

and no probation. The Abughanem Family has learned enough I believe. "The Prophet Muhammed talked about Jesus more than himself" is how you normalize people like the Abughanems. I am also aware that Waleed's lawyer's business partner got raided for his connection to the Mexican cartel. Waleed pulled me to the side during "rec" (walking around circles on the roof) to ask what I thought he should do. I told him he has a locked plea with 18 months and no probation so if John Sinatra gives you more time, call up Jay Ovsiovitich and ask him to fix it.

Has Waleed been psychiatrically analyzed too? I don't know.

Anyway, back to my probation situation. The second of three final points to make is this. Yesterday, May 1st, I sent a letter to Frank Passatiume and Marianne Mariano with all kinds of personal references and how to contact them. I hope the Massachusetts guy speaks to all of them. I naturally want this to come to a positive solution quicker so I am more than happy to put that in writing, too. Not sure how my phone situation will wind up in this room I'm in, so the letters are important obviously.

The third is this. The prosecutor, whatever his name may be, has my permission to subpoena [redacted], Brett [redacted], and Katie [redacted] into the room all he pleases. If you need me to verify this claim over a phone call at this jail as opposed to just writing then I will. Give me one day's notice to your subpoena, give me hardly any time to prepare to see Brett [redacted] and Katie [redacted] and watch me be ready to respond into the courtroom. I am not afraid. Everyone seems to be deep down ready for a subpoena showdown. I am ready. Bring in Michael Crick so he can share with the court over a projector his self-professed family tree connections to James Buchanan and Donald Trump. He's even related to the Quattrones on my mother's side. Bring it the fuck on. Subpoena everyone. It takes signing a legal marriage certificate, an Episcopalian Church marriage at that red brick St Paul's Cathedral in Buffalo, and my Catholic Priest cousin [redacted] blessing the same sex occasion between myself and Benjamin Ryan [redacted] so none of us ever have

this happen again. He turned in Ivan Hunter, my mother spoke to Ivan's lawyer Joe Friedberg when this all started, Ivan used to work closely with Libertarian National Chairman Nick Sarwate, Shut Ivan up and set him back up with Nick. Have me and BRT sign the marriage paperwork in the courtroom since Brett [redacted] absolutely remembers me saying to him "father in law" over text to him in 2020 (and he kept answering texts, might I add, and he got the Moderna vaccine like a good little Confederate after I told him to do so... it says something...), have [redacted] testify about when I told him over a Recon profile findable in my FBI Discovery that yes I would still be with Benjamin Ryan [redacted] take me off probation since you've all heard me on the phones from here saying that since at least February and then leave BRT on it, and everyone is happy. Send Mark [redacted] back to Africa and let him run Carl Paladino's Aunt Michelle's Transgender Hormones Factory. [redacted] absolutely took my side over Mark [redacted] at one point. [redacted] remembers asking me about Benjamin Ryan [redacted] boots and rope fetish. [redacted] is a good little honest Christian who told me to pray over that Recon profile of his. Too bad "prayer" had no meaning to me until Arthur Hubbard was my cellmate at Chautauque County Jail. Anyways the point is, the court has my permission to subpoena anyone into the court with me there.

[as he gets older... I think why I forgot that... Ryan Gury remembers me saying that]


Does this court give a shit about me? Just because you never saw someone speak as boldly as I do over letters to the court doesn't mean I am "mentally ill". I was told the second psychiatrist analysis was equal to the first one from Dr. Rutter. So why didn't this same court push to have me illegally placed into a federal medical center back in August 2023 rather than scheduling me at Horizons like you did? Again I'm happy CCA transfer centers exist and that courts and B.O.P. operate separately. "Play their game" my mother screamed at me on the phone the day my mother's restaurant had Michael Crick as it's honorary customer.

Now I have all kinds of time to masturbate to the thought of Benjamin [redacted] in his new room I'm in as the guy from Massachusetts confirmed over his laptop notes I do. Next I'll write a letter to Jay Ousowitch. He is not very good at answering phone calls. -Luke Wenke
