I am very happy to hear that my father spoke to Frank on Monday the 17<sup>th</sup>. I am very happy that absolutely all officers working at Orleans County Jail have been very courteous and fair to me given my current circumstances. A group of inmates decided to yell and complain to the bald black corrections officer (I do not know his name at the moment) during rec. on Wednesday the 19<sup>th</sup> about circumstances completely out of his reach. I choose to be understanding to this facility's clear lack of funds which is to no fault of the staff here. In these last 2.5 years I have seen no legitimate complaints of corrections officer abuse anywhere in my vicinity.

I prefer to inform the court of more positive details such as these and my desire to express myself in writing, is in no way shape or form a sign of any mental issues or status as being a threat to society as I come from 21 prior years of life of positive social dialogue with people. Frank Passafiume has a very long list of people who have known me for years and ways to contact them who will vouch for my claims.

It gets upsetting and old doing nothing but writing down potential prosecutions against anything taking place as each day passes as I remain helpless to do anything about anything myself. However, now it is my personal self-defense stance to inform the court that my car was illegally driven with an invalid license plate from Buffalo to my house in Olean these last few weeks. I was told about these circumstances on the recorded phone line with my mother. Katie [REDACTED] had my last car repaid in 2022 and this is why my mother called NY state troopers on her in 2022. The court is well aware that she maintains a copied key to my house as we speak and I am already using every capability I currently have to inform the Olean Police about my desire to have my house fingerprinted even as I sit here. I am more than willing to pursue a lawsuit against anyone and anything as further issues such as these continue to pile on top of one another. Street cameras are everywhere these days and I have plenty of dignity left in my system.

\_\_\_\_\_ was recently released from this facility and he tried scheduling an in person visit with me on Wednesday June 19<sup>th</sup> to no influence or request of my own. The jail denied him the visit with me. He too got wrapped up in \_\_\_\_\_'s Suboxone mess and he required a move away from \_\_\_\_\_ too while he was here. This drama is not the usual life for me. \_\_\_\_\_'s judge is Sanford Church.

My phones were searched by FBI twice September 2020 and January 2022. The court is well aware of Michael Crick of the Salamanca Planning Board and who he is to the Salamanca area according to a Google search result. I last recall citing his working presence at a 2012 psychic fair at the Dudley Hotel. He always does allow people to record readings with him. I continue to speak to him very personally while here at Orleans County Jail over the phone and mail. To my knowledge he still has an order of protection against him from his upstairs neighbor at \_\_\_\_\_ in Salamanca and he has a cousin with a life sentence in prison. Michael Crick claims familial relations with former Presidents James Buchanan and Donald Trump through Donald Trump's maternal side. Michael Crick does not just tell people what they want to hear. December 2021 at his home he told me my "drama was catching up to me". January 28, 2022 happened accordingly.

Facebook messages between myself, Katie \_\_\_\_\_, and my first cousin twice removed \_\_\_\_\_ of \_\_\_\_\_ in Portville are out there somewhere. Katie and \_\_\_\_\_ absolutely remember each other. \_\_\_\_\_ has appeared on tv on behalf of the Haunted Hinsdale House, he knows Carl Paladino's family, and \_\_\_\_\_'s grandfather Ercildo Martinelli (my great-great-grandfather) was a St. Bonaventure music professor who played organ for a Pope at the Vatican. \_\_\_\_\_ can vouch for his conversations with Katie, as \_\_\_\_\_ was 56 when he met \_\_\_\_\_ at 15 who he currently lives with. Perhaps one day, everyone gets along again.
