Being fully aware that everything I say in my own handwriting, something that has been documented in this very court's files since January 2022, is legally considered a statement in court (making verifiably false statements in any courtroom gets any defendant a Class A misdemeanor), and being fully mindful that probation employees advised me against sending any letters directly to the court for this very reason (committing a crime to stop a crime is a noted sensation in all countries' courtrooms, i.e. a burglar being rewarded for discovering Anne Frank's family upstairs in a German household), I will start this letter off by summing up it's overall content by saying that this very court case is not unique to the era of American history it is taking place in due to the nature of the interpersonal dynamics involved with all individuals in all levels of interaction of the entire situation, but that being said it is perhaps one of the most unconstitutional sensations taking place in the modern era and explanations surrounding this very concept will be described as well. Thirdly noted, it is possible that this very letter could possibly be destroyed similar to that of all the documentation surrounding the Capital Riot defendants' legal paperwork was handled by this decade's Congress itself. No matter what, word of this court case's long term atrocities will reach the greater American psyche in due time no matter what. "God Is Watching" is an ever present reality over every individual human being who passes through Donald Trump Judge John Siment's federal courtroom where only the chained and cuffed are asked to raise their hand and say "So help me God."

To soothe the self-esteem and confidence of all people presently in this courtroom and to make very clear to all other eventual readers of this documentation, this particular court case is simply an elevated and inflated example of what has gone on among a good portion of Americans since the Covid virus struck the Earth in 2020 as had been prophesized by Missouri psychic medium Sylvia Browne before her death in 2013. Telling people to stay inside and forgo all human interactions with the outside world when the virus first struck produced a person versus person-style domestic war with ourselves a tad bit similar to the story described in the Bible's Book of Ezekiel. When Covid first hit, it became a mainstream talking point on social media among the grassroots masses that we were "going to have a civil war" with

no common uniting cause or overall goal of achieving anything. It all started off with the very existence of the Covid virus itself becoming a partisan talking point, Democrats were stereotypically in belief that the virus was real, Republicans were stereotypically in disbelief that the virus was real. Nursing home lockdowns strangled the emotions of American families, my grandmother Carolyn Giardini (former Justice of the Peace for the town of Carrollton, NY) being one of many nursing home lockdown deaths. "Dying for the economy" became a reality among the medically frail as publicly noted by then-candidate for Vice-President, Kamala Harris. "Open The Economy" protests became a sensation next among working class people, ranging everywhere in between Buffalo, NY's "gridlock Buffalo" protests where people simply parked their cars in the street blocking police movement according to the lead of noteworthy Buffalo residents Carl Paladino and Rus Thompson, to the idea of standing in a fast food restaurant fully armed and loaded in North Carolina as demonstrated by noted national news visionary Benjamin [REDACTED]. Upsetting holiday seasons finished off everyone's 2020 calendar year which was then described as a horrible year. The Capitol Riot then started off everyone's psyche for 2021 with mixed feelings, emotions of ecstasy surrounding the idea of a second 1776 moment coming to emotions of despair from every constituent on behalf of their elected representative on a personal basis. I remember laughing and cheering with joy as I watched average Americans go French on a building chanting "USA, USA", and then I felt upset on behalf of a very visibly shaken then-Congressman Tom Reed, who would later on a year later resign due to sexual misconduct. As 2021 carried on, differences among individuals started to show themselves. Arguments between people got more intense. Covid Omicron struck right after Thanksgiving and this became people's "final straw" moment. British psychic Roxanne Furnival predicted in 2021 for the following year 2022 "a world war" and "a female prime minister". That it became. Years of rift unraveled between our WWII ally Russia and it's southern neighbor our food production source the Ukraine, and years of rift unraveled at it's finest among the American people who for far too long treated episodes of the Jerry Springer show the overall "how" of how the American family operates. I recall meeting many domestic violence cases at Niagara County Jail,

those of which came from "upper echelon" living standard families not typically used to dealing with relatives going through criminal court. "Rise in crime" became national news subjects and the Tops Supermarket Shooter was the peak of it all. Liz Cheney lost her re-election, much to the satisfaction of even jail corrections officers. 2023 followed and differences between people were attempting to settle themselves but still resulting in numerous court appearances for orders of protection violations, as I encountered many of those at Chautauque County Jail.

To paraphrase my purpose in describing my summing up of the collective reality for so many Americans in recent years using the words of my own view over the matter, we get to a point I mentioned in the first paragraph of this letter. This particular court case is an example of what has gone on among people but at an inflated and elevated level, "Rise in loneliness during the pandemic" said the news tabloids as I pathetically wept for an incarcerated human male out in the state of Minnesota while texting his father in North Carolina. My crossing-state-lines domestic issue which made it to the ~~law~~ awareness of this federal court is in tandem with all the other lower level court disputes between people living on other ends of a trailer park. Two grown adult men attaining felonies and orders of protection between way more unsuspecting individuals in the vicinity of their situation is an elevated and inflated example of an average small town romantic couple having an order of protection placed between them. This particular federal court case's interpersonal human atrocities has been a leading example of the domestic human atrocities taking place between far too many people during the Covid years. Due to the relative nature to the era of this very court's movements aimed at the matter at stake, it is to the fault of no salaried employee of the court or law enforcement involved with this situation why the emotions between people have been negatively elongated. All people professionally designated to manage this situation did their job in tandem with all others of recent years performing similar professional duties at lower levels, court and law enforcement.

All that "a war with the government" and "a civil war" as general loosely described statements

produced in the end was a war between individuals with no common cause other than everyone learning "lessons" in the end. Government is of, by, and for the people no matter the circumstances. From local city government employees to members of Congress, all of those human beings have other human beings from all walks of life in their lives. The long term effect of everyone emotionally blurted out "let's have a civil war" when Covid first started has been a huge hurricane tailwind effect of the insurrection defendants and all levels of government employees leading the suffering of confrontation between individuals, moving to the eventual person versus person confrontations involved in everyone's life. I am visualizing a binary star system orbiting itself with one of the stars having a wider orbit path around the larger star which only moves around on it's own at a smaller level as the smaller star whips around. This is what happened when Covid first hit, and this particular court case has been one of several larger stars throwing a bunch of smaller stars out of proportion. Plenty of intense "lessons learned" have occurred on my part these past two years. Disregarding the very unConstitutional nature of this very case I am about to call out in the next paragraph, the time sucked out of my life due to this situation hasn't entirely been served at totally in vain.

Now it is time to call out the unAmerican unConstitutional traits of this very case as it passed through the desks of everyone deeply hypnotized in a "just doing my job" state of mind, ranging everywhere in between overwhelmed lawyers comfortably working towards a 401K as they manage the "criminal court conveyor belt", blindly treating every defendant like a peg on a game of Sentencing Guidelines Battleship, to stenographers being forced to hand-copy and paste every word spoken and written in the court case including the "I'm the dam you're the bitch" vocabulary used early on in this case's original formation, to a judge who worked so hard to attain his professional position that he forgot to have a significant other placed on his Wikipedia page as he's already passed age 50, to the imprisoned former Cattaraugus County Liberatorian Chairman as he sat in P2-40 at Niagara County Jail in awe over the fact that the FBI had accidentally legitimized his personal opinion that Upstate NY should be designated as it's own state called Iroquois by validating the obscure opinion in FBI Discery paperwork, to a probation officer

completely oblivious to the fact that numerous inmates remain at Allenwood Federal prison in White Deer, PA complaining how we are the only country on Earth with probation, to the FBI agents I've known since July 2020 when I asked them about extra restrictions on my front porch and who forgot to request extra ketchup on the food they bought for me in the McDonalds drive-thru on the way to Niagara County Jail. Everyone and their abhorrently "just doing my job" mental psychotic France accidentally produced the most unAmerican and unConstitutional court case not seen since Rochester, NY's Emma Goldman World War One-era conviction, which eventually became one of many to be completely overturned by even the US Supreme Court.

Let's start with Freedom of Speech. How did this case progress from physical mail to [REDACTED]'s personal residence being his first ever sight of what would later on become "this is what Luke Wenke's handwriting looks like" as January 2022's situation would lead to Oct. 2023's accusations? As time has shown, there is no way to prove who is behind an electronic device. It took a Back To The Future Part Two-style "Western Union letter from 70 years ago"-style delivery of an order of protection from North Carolina delivery to my front door in Olean, NY to see if it was me personally behind a now-deleted Twitter (X) account. As this case has shown, all kinds of people have passed through my house with and/or without my permission, and last I knew the Cattaraugus County Police weren't required to wear body cameras at all times. Can you imagine if a house guest had picked up my phone, Tweeted impersonal obscenities at anyone they deemed to be a Retarded Piece of Garbage, and then forged my signature on a United Nations Family Court-issued order of protection from Timbuktu? God Is Watching at all moments of time, and God knows I was taken away from my home as I had just begun employment at Sky Homes Medical Transportation that very week. [REDACTED] and [REDACTED] do not share a website for unsuspecting onlookers to give a one-to-five star rating of their choosing to but I bless them as they discuss business matters by a shared mini-fridge without my ever having met them face to face STILL, and again God Is Watching always. As my vehicle was forcibly left parked in Buffalo against my personal wishes on June, 20th 2023 as it was suddenly decided that the May, 2023 order was suddenly legally considered a probation violation, a week later as I sat in

Chautauqua County Jail without internet to Google search necessary legal information, on June 27th, 2023 a case from Colorado in 2014 similar to my own had been overturned in front of the US Supreme Court. It is a violation of Equal Protection Under The Law to not overturn a plea deal case simply because it didn't go to trial for plenty of reasons. I will continue to lay out as this "History shall repeat itself"-declared letter to John Sinatra's God-fearing courtroom continues below.

In my experience, and again making a false statement in court gets any defendant a Class A misdemeanor, Buffalo NY Uber and Lyft customers are very fond of attempting to tip their drivers in cocaine, something the state of Oregon decriminalized in 2022. I look back at the NY Libertarian Party's workings with fond memories as I recall former state party chairman Mark Glogowski spending a good portion of his life advocating for cocaine's total legalization, and I do recall the Sinatra apartment landlord saying to me on Aug. 10th as he gave my father a tour of his now-apartment that he liked everything libertarians had to say. I recall only having been in Niagara County Jail from January 2022 to April 2022 until a plea deal agreement had reached my awareness via-paperwork. It had only been a few months off the road of driving for rideshare apps that this April 2022 plea deal had happened.

It took up until June-Aug. 2023 at Chautauqua County Jail to finally analyze my mental health's state of being via a mental health analyst of John Sinatra's personal likings, so there was no "borderline personality traits" diagnosis in between Jan. 2022-April 2022. I am very happy to remember the Buffalo NY Sinatra landlord's personal gratitude towards libertarian activism, but on a deeply empathetic human note I want him to remember that although Oregon decriminalized cocaine in 2022, we still lack the science to prove how long the substance itself remains in the human body and its overall effect on the human brain. I want nothing horrific to happen to the health of that Buffalo Sinatra landlord if he and Mark Glogowski were to venture out to Oregon for professional reasons. I apologize for sidetracking, but all I recall in between the months of January 2022 to April 2022 was Alexander Anzalone, who has since abandoned this very case's existence, telling me that plea deals

help us achieve less time than taking cases to trial day, as I sat in Niagara County Jail privately reminiscing on my days as an Uber and Lyft driver in Buffalo transporting healthcare workers to and fro during the initial days of the Covid pandemic. The Bible tells us that God created the government and a Quran here in Cattaraugus County Jail informs me that there is never an atom of injustice in any country's justice system, so my very strong faith and my "God Is Always Watching" approach to life strengthens my personal belief that plea deals achieving any defendant less time is the equivalent to metaphysically informing the heavens that they do in fact regret all negative energies produced due to their own actions which resulted in God himself maneuvering that very **person** into the chained defendant position required to raise their handcuffed hand and say "So help me God". On a solitary and sincere note however, my God those months ranging in between Jan. 2022 to Apr. 2022 were the most somber, confusing, and mentally dazed moments of this entire chapter of my life as I was abruptly taken from my usual life's affairs during Covid Omicron. Fast forward to the present era of November 2023, thank God I am in quite a sober state of mind as I write this very long letter recollecting every moment I possibly can from these past two years as I also sit and recall the many people who have died from fentanyl overdoses. I can only imagine how Home Improvement actor Tim Allen spend his two years incarcerated due to his illegal dealing of cocaine.

Again I shall remind the **readers** of this very letter that we currently live in an era in which Congress itself destroyed so much documentation surrounding the Capitol Riot. Very sad truth because God only knows what was destroyed when Julius Caesar torched Cleopatra's library. If anything were to happen to this very letter before I go to court again on November 21st, 2023, I am very happy that I was the Salamanca High School class speaker for 2010 so I am fully prepared to make similar remarks orally into any Federal courtroom's conveniently placed microphones, but I am also happy that those who have been thrown into Joe Exotic's Federal medical center for life maintain prisoner rights stating that they too have the right to speak to media and say anything they want to Kellen Quigley from

the Olean Times Herald over the phone or letters or even Tullinc's email. Thank God God is watching as America requires only the defendant to raise their hand and say "So help me God".

I bought my house in Olean myself using my own money I worked for. How truly sad it would have been to lose that house as my mother has been forced to pay it's bills while I have been like this almost two years. My father produced me when he was just 20, he divorced my mother not long afterwards, a 1985 NY state "Wenke vs. Wenke" family court decision had even been overturned by the NY Supreme Court before my very existence in this Jerry Springer-esque country helped establish grandparents' rights in NY state Family courts for the first time, my father had lymph node cancer twice, a University of Tennessee college tuition debt to address, three more eventual future marriages after my mother, a failed business venture into SuperTel cell phone store interests in Florida, his current wife's U.S. citizenship status to address in 2022, and an admittedly questionable income status regarding the modern era's "Decision Tree Financial" tax documented business due to my grandfather purchasing him a car in Fall 2022 while I was at Allenwood and due to him frantically calling my mother after that undocumented and unrecorded "recess" conversation that took place outside the court building on November 7th, telling my mother the true nature of his financial and living situation in his Sinatra-owned Buffalo apartment which, according to my mother, he already seems to be falling behind in rent payments on. I am an Olean homeowner who was tear gassed by the National Guard in Minneapolis after arsonists destroyed a police station building. I am very happy I willingly signed papers with probation employees before court on November 7th that they have my permission to speak to Horizons mental health about my brief time there when the leader of group sessions acknowledged that yes, government demanding I exhaust my finances into my gas tank three times a week to go from Olean to Buffalo and back was a legitimate reason to have my "mental health rights" completely violated, as I learned that I have. My father's Third Amendment rights are also being violated as this court is basically now documented as cornering my father into housing me, a private homeowner, in his Sinatra-owned apartment which he already fears eviction from. All because this court rejected the initial validity of the

Olean area CARES facility for more-local mental health sessions. Chief Justice Roberts did validate Obamacare's Constitutionality much to Donald Trump's disgust but as I recall, the Affordable Care Act does allow for the ability to choose your own doctors. I feel sorry for all the people who refuse to support Trump 2024 for whatever reason as their personal safety appears to be at stake these days. Corrections officers at Allenwood gave me extra food in the cafeteria because they saw me as a Trump 2024 supporter "unlike the pedophiles" in their words. We live in an era in which former prosecutors are taking the criminal defense side of things these days. I am very happy that we have three Trump-era appointees outnumbering Chief Justice Roberts personally on the US Supreme Court and I would love to hear their modern interpretation of the Third Amendment regarding government mandating citizens to house "soldiers" against their will.

Constitutional crises are a human rights violation, and I have faith that this federal court's people are dedicated to the Constitution and human rights. Had Adolf Hitler given felonies to the Jews and laughed as they cried for each other after he said "Now you legally can't talk," the US Supreme Court would have swept away all convictions concerning Jews forced apart into separate concentration camps on grounds of Freedom To Assemble. I met Benjamin Ryan [REDACTED] through Vermin Supreme, an FEC documented presidential candidate who has appeared on Jesse Waters' Fox show as well as my own living room before the 2019 Olean Libertarian presidential debate on the Olean High School stage. I sent Vermin's home address to people like Krystie at the Buffalo FBI so everyone could be on a fair playing field before she reminded this very court in June 2023 that myself and [REDACTED] were a longtime romantically involved male-male pair as the stenographers typed away while statements were made. I do recall seeing 2020 Libertarian Vice President candidate Spike Cohen present with Benjamin [REDACTED] in front of me together at the 2020 "Anarcan" event in Virginia as Spike's security detail watched everyone present at the event. The Constitution always won in this country's history on a side-by-side basis with human rights altogether even if it took some time for Americans to wake up to any potential

Constitution and human rights crises taking place at any moment in time. Although Matt Zenger with probation was "just doing his job" as he reported to Katie [REDACTED]'s illegal attempt to have me arrested by the [REDACTED] police before this particular court incident occurred as God continued to watch even without his own personal recording device, I'm sure even he sees the insanity these past two years has done to so many people. It takes fire to fight fire so logic points to fighting insanity with insanity.

Again, I remind readers of this letter that these past two years weren't entirely in vain as similar lower level court situations took place simultaneously. Years of my own internet groups' "vitriol" were noted as I first got to Niagara County Jail. I can't believe it took coming to Cattaraugus County Jail to finally meet my half-brother's half brother Michael Dones. Years of hearing "we are a divided nation" turns out to be because of millions of divisive personal situations taking place. I am thankful to be reading the Quran for the first time while here thanks to somebody with Saudi Arabian and Yemen roots preaching his faith to every last white skinned person in the room on a daily basis. "Not an atom of injustice in any country's justice system" says this guy's Quran. My father Kevin [REDACTED]'s Freedom To Assemble rights aren't being violated when he tries hiring his ex-girlfriend from Yemen Ekram as recently as 2022 while he was finally helping establish his current wife-[REDACTED]'s citizenship from Morocco. I believe I do have faith that finally, as an inevitable second Trump administration appears to be on the horizon, that finally at last this "we are a divided nation" sensation will cease to exist and everyone's Constitutional rights will exist at their fullest to everyone without one example of inequality or misconduct taking place towards one American.


