I sent a letter to Fonda Kubiak apologizing for this past fall. Nothing was her fault, I could have approached situations a better way. She has my permission to work with Frank at any capacity she feels comfortable working.

Better times with Brett ██████████. Helping him come up with homeschool spelling words for his two younger sons, he got Moderna, I helped inform him how Eteya ██████████ once used his house and he was happy when I put her in Missouri accordingly. Brett likes Greek mythology and according to our tablets in here, Hermes blesses same sex pairs. I once saw a picture of Brett and his oldest son at a Smashing Pumpkins concert. Shame on me for not introducing myself face to face in 2020 given the unusual circumstances at the time.

Katie's NY state Trooper paperwork saying she looked schizophrenic is just as much as a legitimate diagnosis as a court suggesting it is in the jurisdiction to send me to a Federal medical center against the B.O.P.'s prior established paperwork on me. Can't place inmates more than 500 miles away

Check the ECMC cameras next. The social workers opinions of the drama of this situation are what scared me. I thought her opinions of the drama would have weight over things. This situation has made me feel cornered too often. Maybe this happened to me because others felt cornered by me...

From home according to B.O.P. policy and there needs to be a conviction involved as it is. I was told the latest psychiatric analysis on me is comparable to July's from Dr. Ruffey, someone known by the Judge for a while. Both psychiatric reports however came after the pre-sentence investigation, probably why Alexander Anzalone and David Rudoff are gone from the case.

Let it be known it does not cost any money to get me to publicly denounce the George Floyd protests or the boogaloo. As I am in here reading Ulysses Grant's memoirs, all was here no winners or losers, just lessons and settlements. I believe popular insurrection in the long run makes domestic violence go up. Fighting families is a sad concept.

Once I got to Orleans County Jail, the Vatican allows Priests to bless same sex couples. My cousin [REDACTED] became a Priest in 2023. My sister [REDACTED] is with a woman. I do not believe this stuff should be forced onto kids, never did. I recall being told through the fake profiles on Recon reasonably suspected to be ran by [REDACTED] that BRT wanted open relationship situation. I asked Fonda recently after apologizing to her to produce a miracle marriage document between myself and BRT. Or else Michael Crick lead me into things?

Let it be known due to where certain legalities are at on my end of things, I am not ashamed to be seen in court by Brett [REDACTED], [REDACTED], Katie [REDACTED] the way Brett and Lauren have seen their son earlier in his life, in court that is. Do we need to sign my [REDACTED] house in Orlean into a joint ownership agreement between myself and BRT to make his relatives happy? The house on the left of my house that's blue and white and the duplex on the right of my house that's white should still be both owned by Art Elliott. Are we getting a Housing and Urban Development loan to put the white duplex into Katie's name too?

Is this "be careful what you wish for" taking place right before our eyes? Is this what I get for prioritizing pictures of celebrities in my 20s over meeting anyone's parents? After we sign the Fonda Kubiak-produced marriage document in this courtroom, does this help make

I am not a public safety threat, I am not a threat to society, and my psychiatric analyses even from the B.O.P. points to the fact that I am not "mentally ill" as the biased court opinion recently suggested I was. Opinions and suggestions made in the courtroom intended on resolving an issue that may seem ludicrous to another suggestion in the courtroom do not make one or any of the parties involved in negotiations "mentally ill". I welcome with open arms this new interview Frank is working up I'm sure the U.S. Marshals will pay for

Reminder that I wanted Benjamin Ryan T [redacted] to fix furnaces in Olean as opposed to choosing Hamas before I even knew what Hamas was. BRT's B.O.P. appointed facility was Butner, not a federal medical center. Equal Protection Under The Law, no more medical discrimination from anybody in the courtroom.
