GOVERNMENT’S SENTENCING MEMORANDUM

“[I] know that this can definitely be an only one-time thing in my life.” That was the defendant’s statement to this Court at his sentencing. Now, the defendant is before the Court to be sentenced for violating supervised release only six weeks after he was released from prison. As discussed below, the defendant’s conduct since his release clearly demonstrates that he has not reformed, he is not ready to be a productive, law-abiding member of society, and he needs additional time in custody to get there. As such, the government submits this memorandum in support of a non-guideline sentence of 12 months’ imprisonment.

A. The nature and circumstances of the offense warrant an above-guideline sentence.

The nature and circumstances of the offense warrant an above-guidelines sentence. On paper, the defendant was convicted of cyberstalking (18 U.S.C. § 2261A(2)(b)). However, the underlying facts and circumstances of the defendant’s conduct, to quote the Court: “read like the prelude to a violent crime.” Sent. Tr. at 14. The defendant engaged in a multi-month crusade of increasingly violent communications directed toward the victim, R.G. When law enforcement searched the defendant’s home, they found, among other things, a document

titled “Hit List,” a document titled “To-do Monday” that included a drive-by shooting, and an AR-platform rifle.

The defendant served an agreed-upon 18-month sentence, was released on March 31, 2023, and almost immediately resumed his alarming behavior. The defendant began posting about R.G.—through not by name—on his social media in April 2023. Screenshots of several such posts are attached as **Exhibit A**. His erratic behavior led to the instant violation when he sent an email to a close associate of R.G., which referenced R.G. several times. This email is attached as **Exhibit B**.

The defendant’s recent conduct has again risen to an alarming level. The defendant may not have technically violated his supervised release until May 13, but he began posting vitriolic statements about R.G. within weeks of release. This, again, “reads like the prelude to a violent crime,” and the Court should consider this when imposing a sentence.

B. An above-guideline sentence is necessary to deter the defendant from future offending.

The defendant’s 18-month sentence on the underlying conviction was the result of a Rule 11(c)(1)(C) agreement. It was ultimately below the 24 to 30-month guideline range calculated by the Court. At sentencing, the Court appeared skeptical of the agreement and asked the parties to justify an 18-month sentence, asking “how do I know that society is adequately protected going forward?” Sent. Tr. at 14-15; *see also* Sent. Tr. at 10 (“[W]hy is this an appropriate sentence . . . [w]hy is it adequate and why is the public adequately protected?”).

In response, the government, among other things, assured the Court that 18 months was, in fact, a harsh sentence for a first-time offender, and assured the Court that 18 months in federal prison was an adequate deterrent to future similar conduct. Sent. Tr. at 10-14. In short, we were wrong.

The defendant's conduct since his release is, itself, proof that 18-months was not an adequate deterrent. But the defendant's own words are even more telling. For example, on April 11, 2023—12 days after his release—the defendant made light of his incarceration in a Facebook post, stating: “It’s Club Fed, not Guantanamo Bay. Hamburger Wednesdays at Allenwood were my favorite Imfao.” A screenshot of this post is attached as **Exhibit C**. Around that same time, the defendant took to Twitter to post “I can’t give a Facebook review for Niagara County Jail . . . Damn, Lol. Excellent bologna and cheese selections three times a week, will make this superb recipe for myself at home since I don’t plan on returning literally ever.” A screenshot of this post is attached as **Exhibit D**.

Even the defendant's most recent arrest on this violation has not deterred him. In fact, the defendant has sent harassing letters to L.T., whose husband, B.T., has a restraining order barring the defendant from contacting him.¹ A photograph of this letter and the envelope it was delivered in is attached as **Exhibit E**. The letter is addressed to “Only [L.T.]” was sent from the Chautauqua County Jail, and is postmarked June 28, 2023—after the Court found that the defendant violated his supervised release by indirectly contacting R.G. This letter was sent with no legitimate purpose, and, given the reference to “Only [L.T.]” immediately

¹ It should be noted that B.T. obtained the restraining order after receiving a series of unwanted letters from the defendant ranting about B.T.'s son and the legal system. The defendant also sent similar unwelcome letters to B.T.'s family members and others who simply share his last name.

after the defendant was made aware that B.T. had obtained a restraining order, clearly demonstrates the defendant's contempt for authority and his willingness to push the boundaries of acceptable conduct.

The defendant's flippant comments about his incarceration, together with his immediate return to violative conduct, make it clear that, contrary to the government's assurances at sentencing, 18 months was not adequate to deter the defendant. More is required. *See* U.S.S.G. § 7B1.4, cmt. 3 ("in the case of a Grade C violation that is associated with a high risk of new felonious conduct . . . an upward departure may be warranted.") As such, the government urges the Court to sentence the defendant to an additional 12 months of incarceration.

C. The Court should impose an above-guideline sentence to sanction the defendant's breach of trust, especially in light of the previous downward departure.

Sentencing for a violation of supervised release "should sanction primarily the defendant's breach of trust, while taking into account, to a limited degree, the seriousness of the underlying violation and the criminal history of the violator." U.S.S.G., Chpt. 7(A)(3). Indeed, that is why the Sentencing Guidelines counsel that "where the original sentence was the result of a downward departure . . . an upward departure may be warranted." U.S.S.G. § 7B1.4, cmt. 4.

Here, the Court trusted that a below-guidelines sentence of 18 months would be adequate. Despite its reservations, the Court showed leniency to the defendant. The defendant, in turn, betrayed the Court's trust and violated his supervised release almost

immediately. Showing the defendant leniency yet again would only serve to reinforce the defendant's apparent belief that supervised release is a suggestion, and that the rules somehow do not apply to him. To appropriately sanction the defendant's violation of the Court's trust, the Court should impose a sentence of 12 months' imprisonment. Twelve months for the violation, when added to the 18 months served on the underlying conviction, makes a total sentence of 30 months—the upper limit of the defendant's original guideline range. As such, the government submits that a 12-month sentence is appropriate.







Subject: George Floyd is dead and that's a good thing

Hi I never did introduce myself in this direction before!

What an awful experience I have had with your city of Minneapolis and your criminal defense industry altogether! I never got arrested my entire life until age 29 when I made the mistake of having a heart for your client Benjamin Ryan [REDACTED]. He acted like he was stranded out there so I came driving out there to be with him for a week. He got arrested September 2020, the word entrapment wasn't even in my vocabulary up to that point, and so I found myself physically crying for a stranger harder than was normal. I thought he was just an activist and a demonstrator out there up to that point, why FBI would treat a jobless American like a jihad was beyond me up to that point. A few months later boom went that Capitol and that was a very good day given the shit state this third world country I unfortunately live in is in. I did not know at that point that he blew up the police station. I decided that when third world countries like our's have wars on the homefront, people who should be honest with each other and on each other's side end up pleading the Fifth about everything.

Over a year went on and your comrade [REDACTED] continued to make fake Recon profiles speaking to me very impersonally when he could have just spoken to me directly. The best I can say is if you and your significant other were torn by Nazi lawyers and thrown into separate prisons, you would cry for each other and you would get very hasty towards the Nazi lawyers who keep acting aggressive to you. I even had a paying client for [REDACTED] from the Capitol Riot, Daniel Christmann, but none of my continued efforts to be nice face to face as I have always been for years with many people ever played out with that stranger who will never have the privilege of meeting me.

During Covid Omicron my house was broken into by a neighbor who is no longer next door to me and I was living by myself the whole time going through everything Covid gave me. After over a year of not being allowed to talk to [REDACTED] and everyone acting like he was my queer significant other, I flipped out and gave up since this is a natural human reaction to Nazi lawyers "attorney client privilege" as they called it. Turns out that stuff CAN have negative impacts given what happened to me in the end. You all kept me in the dark and even crying way too hard than was normal. Nobody ever felt threatened by me before. I haven't even punched anyone since high school and that was over cafeteria milk.

So [REDACTED] the former head of all your state's defense lawyers got me arrested for the first and last time at age 29 and he never even met me. I am so fortunate to have all of my things back like pictures of your client Ryan [REDACTED] with Gary Johnson at age 14 in 2012 so I can maybe one day buy ads in Wilmington newspapers one day and say "Gary Johnson creates cop killers" since the Libertarian party both [REDACTED] and I know each other from created a cop killing drug dealer out of him. I will be going the Trump 2024 direction since the 52 year old Libertarian party (where Ivan Hunter also comes from having worked with Nick Sarwark before) made a 31 year old incel out of me. After being thrown into separate prisons, [REDACTED] put "it didn't work out between these two" in the court notes as I had to sit and listen and swallow the intense emotions in handcuffs in a court room about what he said. After him not letting me and him talk, after him relaying messages from [REDACTED] to me over Recon with [REDACTED] asking if I'd love him when he is old to which I said yes, this is what your wonderful colleague did to me.

So thanks for the felony, Minneapolis defense lawyers. I already want it gone because I have dignity and I don't deserve this. I can only imagine if Brett and Lauren [REDACTED] or if [REDACTED] were torn from bed by Nazi lawyers while fornicating each other and thrown into separate prisons and then the Nazi lawyers say "It didn't work out between these two", I can only imagine how awful they would feel. This is what your

city's defense lawyers did to ME. Now it's illegal for me and [REDACTED] to speak. Good job guys, now he and Elexya [REDACTED] aren't separated by probation. Awful job you guys did stopping crime because those two used to raid ATMs together and their pro-homeschooling family knows this. I'm the one who wanted [REDACTED] to fix furnaces here in my town but then he decided to be a sand nigger jihad and chose the Hamas route.

This is what you people did to me out there. I can't tell you how much the Minneapolis defense industry has made me hate America. Over a month back home and this "finding a job" bullshit is difficult since I live in an impoverished rural area and Uber and Lyft was perfectly fine for me. But I won't give up. Your city's defense lawyers divided two people who meant well. Your city's homophobic lawyers are too pompous to realize what it would feel like for couples to be torn by well off Nazi lawyers wearing powdered wigs and to go through this never ending bullshit I keep going through year after year.

Who am I to [REDACTED] at this point? Probably nothing. Someone he knew for two weeks face to face. Someone he was divided from because of your state's Nazi chief lawyer [REDACTED] who kept serving as a secret middleman on Recon as my FBI paperwork proves not allowing us to speak. I'm happy George Floyd was killed at this point, that guy is someone I would have called 911 on. And I was trying to do that to my neighbor here in Olean after my house was broken into. Olean Police said come help us with your neighbor, I showed up at the police station, there's FBI to get me after a defense crime profiteer I never met issued the arrest. I was a taxpayer who was lied to, quite a different entrapment.

Thank you for ruining the otherwise positive relationship between me and [REDACTED] Minneapolis defense lawyers. Thank you for the felony but I would like it gone NOW. I never made anyone feel threatened by me before. I will include a picture of me, my mother, and state senator George Borrello from May 2021 in this email so you can see I'm not a gang thug.

Thanks for making someone you people never met a 31 year old incel with no relationship history and with a felony. "Luke went down for a dude who never gave him dick" is what they're saying now. This is embarrassing on my end up to this point. Thanks for legally dividing [REDACTED] from the one who wanted well for him, now he can go back to raiding ATMs with Elexya [REDACTED] like before. Excellent job, you guys. Thanks for letting me cry as hard as I did late 2020 early 2021. I didn't even know the word entrapment up to that point. Andrew and Khrystie from the Buffalo FBI assumed I knew he blew up the police station but no I didn't. Assuming has definitely made an ass out of u and me. Thanks for killing my American experience, leading me on for over a year, and now making me less free. I sure do hate this shithole country because of your city's overpriced defense lawyers who waged class warfare on me and got my prior income shot. What a loveless country I live in and your defense lawyers have taken away a very basic human need from me since you're all a bunch of human rights violating animalistic Nazis. I am a 31 year old incel thanks to your fine work.

So again thanks for nothing to your city's criminal defense industry. I don't enjoy your city whatsoever. George Floyd is dead and that's a good thing. By the way I don't know who out there talks to Tanikka but I'm not naive, she found me online the week I got home. Also your client lied about my grandfather's hunting rifle. This is never ending drama and I am going to continue to carry it on and on and on until things are solved to my liking.

Thanks for aggressively breaking up two good people you homophobic shit lawyers. It's been since September 2020 I talked to [REDACTED] early 2021 over Recon through [REDACTED] (a homophobic rice bag I NEVER want to meet), thanks for the felony I've already earned a pardon from, thanks for the sad memories. You people did nothing for me, a stranger you never met. You jacked my income and you lied to me. Now [REDACTED] and [REDACTED] can go back to raiding ATMs in peace since I was apparently the piece of shit all along since criminal defense lawyers WANT crime to continue so they can keep making a profit.

Have fun living with yourself profiting off violent crime rises, I never needed a defense lawyer before and once this is finally off my record I will never need one again.





Just a guy in jail whispering sweet nothings to [redacted] I think that's [redacted] with brown hair standing with Gary Johnson and some 14 year old midget in that picture I got hanging right by that glue I may or may not still have hanging from my ceiling fan at the house I will STILL be returning back to I don't know, I have another picture of someone with someone else at a Smashing Pumpkins concert. Maybe I'll hand those pictures over to Kevin Bartholomew who wrote a letter to my Donald Trump appointed judge John Sinatra last year and in 2023 may or may not be behind that mysterious Olean Trump 2024 Twitter page. Hmmm...

Now I need to tell you about someone else who continues to be connected to both your's and my own situation. Her name is [redacted] She lives in [redacted] with her parents. She sugar bitched her way through NYU, and to this day she continues to sugar bitch her way through the world at 35 years old. There is FBI documentation available in my immediate possession of her immediate contact with an unnamed Federal authority from January 2022. Now everyone in my immediate circle can confirm that it was likely her behind that 716 burner number that recently informed me that when we star 6 7 call people's numbers for shits and giggles, we can still find out who was behind that star 6 7 call. That's what she told me over a burner number.
