NARRATIVE

On 01/25/2024 while stationed at Salamanca High School 50 Iroquois Drive Salamanca NY 14779 this deputy was approached by building Principal [REDACTED] regarding a letter he had received. The letter was sent from a former student Luke Wenke (suspect) who is currently incarcerated at Orleans County Jail located at 26 Platt St. Albion, NY 14411 and is being held there for the US Marshals Service. The letter was addressed to SHS for the attention of Mr. [REDACTED] and current Seneca Intermediate School band teacher [REDACTED] who also attended Salamanca High School with Luke Wenke. The letter (see attached) covered several topics including how he became incarcerated and was 6 pages long but did not threaten the above mentioned parties or school.

On 03/11/2024 a second letter was received by SHS from Luke Wenke to the attention of Mr. [REDACTED]. The second letter was two pages long and addressed Mr. [REDACTED]'s upcoming retirement among other topics. There were no threats in the letter towards Mr. [REDACTED] nor the SCCSD. This deputy then called the U.S. Marshals Service Western District of New York and spoke with Vince Downey [REDACTED] who is associated with Luke Wenke's case. Mr. Downey informed this deputy that their office as well as several other judges, attorneys, and others are receiving letters from Mr. Wenke around the same dates and are similar in language to the letters received by SHS. At this time there are no charges for Luke Wenke from the letters and this is for documentation purposes only. Case will be closed at this time.
