


1. I/I has been issued a complete set of linens and uniforms.
2. I/I has been issued a tablet and/or prisoner handbook containing facility rules and information in accordance with minimum standard 7002.9.
3. I/I is responsible for understanding and complying with the contents and requirements of the prisoner handbook. In the event of illiteracy, and/or language barriers, staff will assist the I/I as necessary.
4. The Niagara County Correctional Facility is a non-smoking facility. I/I's are not permitted to possess any tobacco products or incendiary devices at any time during incarceration.
5. I/I has been issued an identification bracelet. Unless medically warranted, the ID bracelet is to be worn on the left wrist at all times while incarcerated at the NCCF. I/I is responsible for the notification to staff when bracelet is in need of replacement. Any individual who refuses to wear the ID bracelet shall be subject to disciplinary sanctions up to and including loss of exercise privileges, programs, visitation, commissary or other activities as determined in writing by the Chief Jail Administrator.
6. I/I is responsible for all articles of clothing issued by the facility. If found to have misused or destroyed facility property, the individual may be held liable for restitution to the facility for the value of the item.
7. Upon release, the NCCF shall hold an I/I's property for a period of thirty (30) days. If the property is not claimed or picked up in this time period, all property shall be destroyed. It is the responsibility of the I/I to make arrangements for all property items left behind upon release. If an individual requires property to be mailed, I/I's are responsible for all costs incurred for shipping.
